## AMENDMENT TO THE CALL

In 2023., the second year of project implementation, two new partners joined the RIS Internship consortium from CLC South; Agencia Estatal Consejo Superior de Investigaciones Cientificas M.P., CSIC (Spanish National Research Council) and Consiglio Nazionale delle Ricerche, CNR (National Research Council of Italy), accompanying initial RIS Internship consortia, mainly focused on recruitment of the companies and students from CLC East. From the opening of the call for students in February 2023 to June (middle of project implementation for the second year), twelve new organisations from Spain and one organisation from Italy joined our Pool of organisations. Additionally, more than hundreds of students' applications were received in the first four months and many of them were directed at Spanish organisations and are being in processing at the moment of writing. From May, couple of international students created an internship with organisations from Spain, meaning that the increased mobility between CLCs occurred. Taking into account the long travel distance, high expenses of food, accommodation and transport in Spain, especially during summer, the need to introduce a new category of Internship fees occurred. Thus, we added the final and maximum category of 800 EUR Internship fees which relates only to cross CLC mobility. More specifically, students from ADRIA Region and East European countries that match with organisations from Spain, Italy, or Portugal for an Internship, will receive 800 EUR fee per month of internship implementation. The same goes vice versa for students from Span, Italy or Portugal and organisations from ADRIA Region and East European countries.

In this manner, the entire call for applications for students and organisations to RIS Internship programme will be extended **until 10<sup>th</sup> November 2023.**, to ensure enough time for this amendment to be perceived.









## Maximum amount of the financial support

Financial support to the selected Interns will be categorized as "scholarship" and will not exceed 800 € per Intern per month i.e., 2400 € for the maximum Internship duration of three months. The amount in question will be awarded as a monthly lump sum, without any additional cost justification needed, as presented in the following table.

Internship implemented in the radius up to 50 km outside the settlement where the intern studies	300,00
Internship implemented in the radius larger than 50 km outside the settlement where the intern studies	400,00
Internship implemented in the location outside the country of the intern's study*	600,00
Cross CLC mobility **	800,00
Internship carried out online	150,00
